Discussion Items

- Sprinkler system
 - Coverage is only on equipment; not liability
 - The equipment valuation under the current coverage wouldn't cover the current costs to repair/replace it
 - Brad is optimistic that the city will help us get to a solution; all parties involved (city, foundation, property owners) are vulnerable in the current situation
 - We are looking for stopgap coverage in the event that it isn't resolved by April 5th
 - Additionally, HVJF should move the contract to an LLC that separates it from the foundation's assets
 - Possible options for property owners are...
 - Affected property owners form a group on their own accord that agrees to co-own and administer only the system's shared distribution line (\$)
 - Each owner installs their own sprinkler water main (\$\$\$)
 - Fire Marshal shutdowns property based on business type
 - Only retail could exist in these properties
 - Next steps...
 - Legally must send out a notice by March 3rd to affected property owners that we do not plan to operate the shared line after April
 - Plan a meeting with property owners to begin roundtable discussions
